ITS PRIMARY PROGRAM IS THE SWAG SOCCER PROGRAM, A NO-COST SOCCER TRAINING PROGRAM FOCUSED ON OPPORTUNITIES FOR YOUNG ATHLETES, AGES 4 THROUGH 9 FROM PHILADELPHIA'S AFRICAN AMERICAN AND IMMIGRANT COMMUNITIES.
